Digital Learning as the Mode of Study on the IQ Digital Campus

Studying through the IQ Digital Campus provides a flexible, modern, and fully supported learning experience. Our digital learning model is designed to help you succeed through independent study, self-paced learning, and high-quality digital resources, including structured video lessons, animations, interactive quizzes, and guided assessments. The information below explains how your digital learning journey unfolds from enrolment to completion.

1. Enrolment

Your learning journey begins with a simple online or in-person enrolment into your chosen qualification.

Once your registration is complete and your payment is processed:

- Your learner profile is created
- Your Digital Campus access is activated
- You receive your login details
- You receive your provisional Training Plan
- You are guided on how to begin your programme

This marks the official start of your academic journey with IQ.

2. Induction Programme

All learners must attend the **compulsory Induction Programme**, which prepares and orients you before academic activities begin. During induction, you will be introduced to the structure, expectations, and support systems of your qualification.

a. Programme Structure

5. **Assessments follow learning**

Once a module's content is completed, you will receive instructions on submitting tasks, workplace evidence, or preparing for your formal assessments.

Independent Digital Study

The Digital Campus model does not include a daily classroom teacher. Instead, you study independently with full access to support when you need it. This means:

- You manage your own learning pace
- You may rewatch lessons as often as necessary
- You take responsibility for meeting your deadlines

This approach builds confidence, discipline, and independence—qualities valued by employers.

Programme Mentor Support

Although learning is self-paced, you are **never alone**. Every learner is assigned a Programme Mentor who:

- Respect all Digital Campus policies, procedures, and deadlines.
- Track your progress using the platform's indicators and alerts.
- Communicate respectfully with all staff, mentors, and workplace supervisors.
- Keep your personal information up to date and inform IQ of changes that may impact your studies.
- Protect your login credentials and never share your account information.

8. Communication Channels and Turnaround Times

Learners are encouraged to use the appropriate communication channels for support:

IQ is committed to responding to learner queries within reasonable turnaround times, ensuring efficient support throughout your studies.

9. Digital Assessment Process

(To be read in line with the official Assessment Policy)

All assessments on the IQ Digital Campus follow a controlled, secure, and transparent process to ensure fairness and authenticity.

a. Theory Assessments

- Assessment dates and times will be provided in advance.
- Learners log into the Digital Campus and access the assessment portal.
- Cameras must be on throughout the assessment for proctoring and authenticity verification.
- Once completed, learners click the **Submit** button to finalise their assessment.
- The assessor downloads, marks, and records the assessment.
- Results, including remediation (where required), are provided within **14 days**.
- Learners who do not achieve the minimum pass mark will be granted a rewrite opportunity.

b. Practical Assessments

- All practical tasks must be completed and recorded in the Practical Workbook.
- When a demonstration is required, learners must include a video recording or video link as evidence.
- Practical assessments are conducted at the workplace in an **in-camera session** with the programme assessor.

10. Summative/EISA Readiness Requirements

After completing all modules and submitting all required evidence:

1. The Programme Mentor verifies that your workbooks and assessments are complete.
2. You will receive a formal letter confirming readiness for the External Integrated Summative Assessment (EISA).
3. IQ will provide an EISA preparation session to help you revise and understand what to expect.
4. As the EISA is an external exam scheduled by the QCTO, waiting periods may apply; learners will be kept informed.
5. IQ accredited sites serve as assessment centres. If you are not near an IQ centre, you must write at the nearest approved venue.

6. Some centres charge a venue fee—this cost is not included in your course fees and must be covered by the learner.
